DATE: February 24, 2021

At the February 23, 2021, bid opening for the renovations to Henry J. Kalk Park, five qualified bids were received and opened. The initial budget estimate for the construction phase of this project is \$267,000.

The bids were favorable, with both the base bid and alternate #1 below the project budget. Alternate #1 is the plaza. This positive result is due to the following:

- COVID-19 related competitive bid environment
- Excellent bid documents developed by Altamanu/CBBEL.
- A portion of the electrical work was removed from this contract and completed as part of the Connect Glencoe Project.
- Sod was removed from the contract. Staff will be seeding the park for a lower cost with a higher quality outcome than sod.

The initial budget estimate for the construction phase of this project is \$267,000. The base bid, alternate 1, and an allowance for work to be completed by Park District staff is projected to cost \$230,000. The project is approximately \$37,000 (13%) under budget. However, with the unknown condition of the retaining wall, staff recommends leaving the construction budget at \$267,000.

Per the bid document, we are awarding the project to the lowest qualified bidder. Based on the competitive bid price, staff recommends awarding alternate 1.

Therefore, the lowest qualified bid is from Integral Construction of Romeoville, Illinois, for \$205,832. This includes base bid and alternate 1. Integral provided excellent references, with experience in landscaping, playground construction, and drainage improvements.

Recommended Motion: The approval of the lowest responsible bidder, Integral Construction of Romeoville, Illinois, for a total of \$205,832.
